Amended Articles of Association

External legal firm (Hugh James) was commissioned by Welsh Athletics to conduct a light-touch legal compliance review of the company's Articles of Association (as adopted in 2023 AGM).

The independent legal review identified several minor amendments to enhance clarity and ensure compliance, alongside general tidy-up revisions and insertion of new standard articles.

The legal firm drafted revised articles incorporating the recommended amendments.

For reference: Proposed insertion of new provisions

The company members limit of financial liability (each member limited to £1)

3.19. The liability of each member is limited to £1, being the amount that each member undertakes to contribute to the assets of the Company in the event of its being wound up while they are a member or within one year after they cease to be a member, for:-

- 3.19.1. payment of the Company's debts and liabilities contracted before they cease to be a member,
- 3.19.2. payment of the costs, charges and expenses of winding up, and
- 3.19.3. adjustment of the rights of the contributories among themselves.

How remaining funds and assets are treated on winding up or dissolution of the company.

- 28.1. In the event of a winding up or other dissolution of the Company, any funds and assets remaining after satisfaction of its debts and liabilities and the costs of any winding up or other dissolution:-
- 28.1.1. may not be paid or distributed to the members; and
- 28.1.2. must be transferred to one or more entities (whether incorporated or unincorporated) that:-
- 28.1.2.1. have the principal purpose of the administration and development of athletics in Wales; and
- 28.1.2.2. have restrictions on the application of their property (including, without limitation, any dividend, bonus or other distribution of any kind whether as income or capital or in the form of cash or otherwise) at least equivalent to the restrictions applicable under these Articles.
- 28.2. If that is not possible, they shall be transferred to or applied towards some other purpose or purposes that are charitable in the promotion of sport in Wales under the law of England and Wales.
