***Notes on Nominations***

- 1. Nominations may be made by affiliated clubs via their appointed Company Member (or nominated proxy), and must be seconded by another affiliated club via their appointed Company Member (or nominated proxy).*
- 2. Written evidence will be required that the nominated person is prepared to hold office, together with the nominee's full address.*
- 3. All current post holders are eligible for re-election.*
- 4. In the event of more than the specified number of nominations being received for any of the above offices, posts, delegate positions or memberships, a ballot will be held at the AGM. In the event of no nominations being received in advance for any specific post, nominations will be accepted from the floor on the day of the AGM.*
