# 7. Update to CRM/IT System

Presented by AT. A requirement for programme and membership management tool was identified through the recent junior membership project. The current platform is dated and does not meet the requirements. Discussions have been had with UKA and England Athletics to phase to a cloud -based system. AT to provide regular updates on the process to the Board. The Board are excited about the project providing the sustainability of the system to be able to future-proof.

## 8. National Development Programme Update

Presented by CT. Current athlete standings are as follows: World Class Programme (WCP) – 9, Performance – 5, Transition – 16, National Development Programme (NDP) – 75. 9 athletes were deselected in 2025 with exit plans or re-entry targets. Current key learnings are:

- Flagged athletes from 2024 season showed the biggest rates of progression within their event groups
- 2024 cohort was over captured strategically but resulting in athletes being flagged in 2025.
- Athletes and coaches who don't engage are less likely to progress through the system
- The sprints pathway is least engaged with Athletes struggling to progress through transition level
- Structure change to incorporate more bespoke event specific development
- More contact time with Athletes and Coaches is the key

Wales are in a good place for the CWG so far with 6 at A standard. CT presents the timeline until the CWG, including warm-weather training camp, nominations, selection and holding camp.

LB questions coach engagement when an athlete gets selected for programmes. LB also asks what support mechanisms are in place for deselected athletes. CT answers that the flagging process can last as long as it needs to support the athlete.
