# Minutes written by Christine Vorrés 11 June 2025

#### General Council – Report of the Welsh Athletics General Council held on 7 May 2025.

- 1. Actions from previous meeting
  - Lack of Safeguarding courses Lynne Briar(LB) reported that this matter had now been resolved.
  - Welsh Athletics proposed webinar re age group changes LB to discuss this matter with James Williams (JW) CEO to determine when this webinar should take place. Whilst this matter has already been discussed with the Track & Field Committee these changes need to be communicated to the whole sport.
  - Officials' expenses and refreshments there is still no response from Welsh Athletics.
  - South Region is still not represented on the General Council. It was suggested that JW CEO should meet with members of the region to address this issue. LB also suggested that the General Council meet with representatives from the South to discuss and support the way forward.
  - 2. Review of Welsh Athletics from a young person's perspective. With the support of Sport Wales Katy Evans has been appointed to review the recruitment and retention of young members in our sport as well as the identification of areas for growth. Katy will be attending the next meeting of the Council when hopefully we will have a progress report.
  - 3. Regional matters.
  - Race Licenses Track and Field licenses now cost £200.00. Regions can apply for a license to cover all events for one fee. This will apply to Track and Field only now as the endurance portal is not up and running! Track and Field Licenses for clubs will be £25.00 for 2025 and £26.00 in 2026.
  - Stripe Accounts each region will have its own account to pay for events next year. It was reported that the West Region already have such an account.
  - 4. Reports. Road & Cross Country- confirmation of dates.10 K series
  - May 11th Caerphilly Bryn Meadows
  - July 7th Porthcawl.
  - July 20th North Wales Helina Tipping.
  - September 14th Swansea Bay.
  - 5, Introduction of a £75.00 charge to athletes when selected to compete for Wales abroad. Concern was expressed; LB was charged to express these concerns to Welsh Athletics.
  - 6.JW joined the meeting towards the latter part of the session and confirmed the following The need to impose a financial contribution for athletes selected to represent Welsh Athletics abroad. The reason for

engaging Katy Evans to address recruitment and retention issues relating to young athletes. The representation of the South Region and Welsh Schools was also discussed. It is hoped that suitable representatives will be added to the Council in the near future. Lynette Harries

#### East Wales Mountain & Fell Report 2024-5

## **Regional Championships and Races**

The 2024 junior championships were held once again at Llanthony Priory with the senior champs at Coity on 14 June. Thank you to Dmitri and Chris Vorres for once again applying for the WA licence. Going forward, we will no longer need to apply for WA licences if we use WFRA licenced events. This is because WA have accepted WFRA licenced races as valid for championships and trial races in Wales. Thanks must go to the East Wales committee in pushing for this change, which provides significantly more racing opportunities for us to use. For example, there is a series of 6 licenced junior races in South Wales in 2025, the next of which takes place from the Fforest Fields campsite near Builth on 28 June.

## **Regional teams**

Last year, a senior team attended the inter-counties races held at Kesiwck on 23 April 2024, comprising 3 male and 1 female runner. The 2025 senior and junior race are both being held in June. A senior team is almost complete and we hope one or two junior runners will come forward, although the distance to the races (in Yorkshire and Lancashire) is proving a barrier to competing for some.

#### Development

A junior development day was held in conjunction with the South region on 5 April 2025 at Llanfoist. The event was successful, with some track and cross country runners joining some seasoned fell juniors training on the Blorenge. We look forward to continuing the development programme and to that end a Spond group has been set up for all athletes in Wales who are interested in fell running. This is used to make athletes aware of local, intercounty and international racing and trial races, as well as development days and a forum to ask questions of the Welsh mountain running committee members.

#### International representation

We have again had some very strong performances from regional runners who have progressed from East Wales to Wales representation, the latest being Lucy Williamson racing in Italy and Will Chalk being selected for the U18 Mountain Running Cup in Slovakia, to take place shortly. Congratulations!
